**A. Executive Summary**

Section 284(1) of the Municipal Act, R.S.O. 2001, requires the Treasurer of every municipality to prepare and submit to Council by March 31<sup>st</sup>, each year, an itemized statement of the remuneration and expenses paid to each member of Council in respect of their services as a member of Council in the preceding year.

In compliance with this Legislation, the attached is the statement of remuneration and expenses for 2023. Remuneration amounts are based on the Employee Income of the Mayor and each Councillor as defined by Canada Customs and Revenue Agency (T4's). Expenses include all travel related expenses incurred by members of Council.

As the report is prepared based on when payments are made, expenses can include items prepaid for 2024 and settlements for items that occurred in 2023. The settlements in 2023 could be related to items/events that occurred in 2022.
