3. Ensuring construction of the pool enclosure occurs when the pool is completely empty and not filled with water;
4. Ensuring that no portion of the pool enclosure encroaches upon City property or neighboring properties;
5. Carrying out the work on the pool enclosure and erecting the pool enclosure in accordance with the requirements of the Pool Enclosure By-Law;
6. Applying for and received a Building Permit, Park Access Permit, and/or a Road Work Permit if required;
7. Ensuring that perimeter grades are not altered, that the construction will not impact the drainage on adjacent properties, remedying any future drainage concerns resulting from this construction;
 - a. If the final grading has not been completed and approved by the City of Waterloo at the time of permit issuance, the Owner understands that they are proceeding with construction at their own risk.
